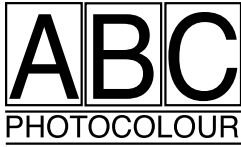

Cancellation of the account will not relieve you of your obligation to pay the outstanding amount at the time of cancellation. Our minimum invoice amount is \$25.00. Smaller orders may be handled C.O.D.

Full payment on overdue invoices required within 30 days of the invoice date. Interest on overdue amounts will be charged at a rate of 2% per month (24% per annum). The entire balance outstanding shall at ABC Photocolour's option, become immediately due and payable. Due to our computerized billing system, an account which is 60 days past due will automatically be converted to C.O.D. status without notice. ABC Photocolour will not be liable for any delays in the shipment of your orders due to your account being 60 days past due. Your account will retain C.O.D. status until the overdue balance is cleared. ABC Photocolour reserves the right to close any account which repeatedly becomes 60 days overdue.

All orders are subject to Federal and Provincial taxes. Proper certification for tax exemptions must be given prior to invoicing. No refunds will be given for tax exemptions not claimed at the time of invoicing.

Inquiries on invoices must be made within 10 days of the invoice date or the invoice will be considered correct and final. A Search fee of \$1.00 per invoice will be charged for copies of the invoices requested 30 days of the shipment date on which the invoice first appeared.

An account which has not been used for three consecutive months will be closed without notice. A new credit application will be required to re-open a closed account. Prior to credit approval, all order will be C.O.D.
